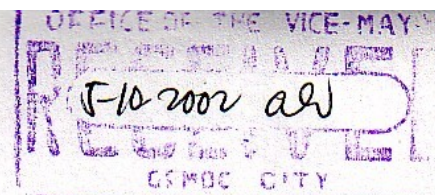

RESOLUTION NO. 2002-113

A RESOLUTION REQUESTING THE NATIONAL HOUSING AUTHORITY
(NHA) FOR RESETTLEMENT ASSISTANCE UNDER THE SUBSIDY
FUNDS OF SAID AGENCY AND APPROVING THE BARANGAY CURVA
RESETTLEMENT SITE AS THE RECIPIENT OF SAID ASSISTANCE.

WHEREAS, in view of the immediate need to establish a resettlement
project in the City of Ormoc to accommodate poor families requiring
relocation, the City Government has allocated a total area of 6.18
hectares more or less as resettlement site located at Brgy. Curva, this
city;

WHEREAS, in order to develop said resettlement site, the City
Government of Ormoc is seeking the assistance of the NHA it being the
sole national government agency engaged in direct housing production
mandated to meet the housing needs of low income and marginal families;

WHEREAS, said project is intended to provide housing assistance to
low-income families who may qualify for housing resettlement assistance
and those families occupying danger zone and areas reserved for
government infrastructure;

WHEREFORE, foregoing premises considered, on motion of City
Councilor Eduardo P. Tan, Chairman, Committee on Urban Development,
severally seconded by City Councilors Gregorio A. Yrastorza, Jr., Jose
S. Serafica and Ruviniou E. Mendola ; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution REQUESTING THE NATIONAL HOUSING AUTHORITY (NHA) FOR RESETTLEMENT ASSISTANCE UNDER THE SUBSIDY FUNDS OF SAID AGENCY AND APPROVING THE BARANGAY CURVA RESETTLEMENT SITE AS THE RECIPIENT OF SAID ASSISTANCE;
