

RESOLUTION APPROVING ORDINANCE NO. 2002-001 OF THE BARANGAY COUNCIL OF BARANGAY STO. NINO, THIS CITY, ENTITLED: "AN ORDINANCE REQUIRING OWNERS OF ALL RESIDENTIAL HOUSES AND SIMILAR BUILDINGS, CONSTRUCTED WITHIN THE JURISDICTION OF THIS BARANGAY, TO CONSTRUCT SANITARY TOILET WITHIN ITS PREMISES, OR AS PART AND PORTION OF ITS COMPOUND, PROVIDING PENALTIES FOR NON-COMPLIANCE THEREOF".

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No. 2002-001 of the Barangay Council of Barangay Santo Niño, this city, "AN ORDINANCE REQUIRING OWNERS OF ALL RESIDENTIAL HOUSES AND SIMILAR BUILDINGS, CONSTRUCTED WITHIN THE JURISDICTION OF THIS BARANGAY, TO CONSTRUCT A SANITARY TOILET WITHIN ITS PREMISES, OR AS PART PORTION OF ITS COMPOUND, PROVIDING PENALTIES FOR NON-COMPLIANCE THEREOF";

WHEREAS, this Sangguniang Panlungsod ng Ormoc, in relation to the aforecited Ordinance at issue (and all other ordinance of the Sangguniang Barangay in Ormoc City) is by law, granted the Power of Review as to whether said ordinance is consistent law and city x \times x ordinances; (Sec. 57, 1991 LGC)

WHEREAS, it is the observation of this august Body that the aforesaid ordinance has conformed to pertinent provisions of the Local Government Code, hence, reasonable and within the province of the Sangguniang Barangay of Sto. Niño to legislate;
