

EBOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMELO LOCSIN TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, A MEMORANDUM OF AGREEMENT WITH THE NATIONAL HOUSING AUTHORITY REPRESENTED BY ITS GENERAL MANAGER, EDGARDO D. PAMINTUAN, FOR THE DEVELOPMENT OF A RESETTLEMENT PROJECT IN BARANGAY CURVA, ORMOC CITY.

WHEREAS, this august Body is in receipt of a copy of the Memorandum of Agreement between the City Government of Ormoc represented by the Honorable City Mayor, Carmelo J.
