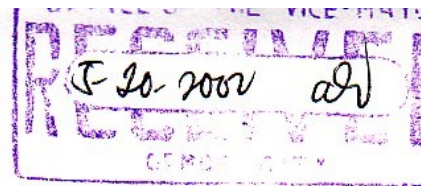

A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE  
AGAINST PRIOR YEARS OBLIGATION THE AMOUNT OF FIFTEEN  
THOUSAND PESOS (P15,000.00) FOR THE PAYMENT OF MEAL  
EXPENSES INCURRED DURING THE THERAPEUTIC COMMUNITY  
SEMINAR FOR PROBATION AND PAROLE OFFICERS HELD LAST  
DECEMBER 21, 2001.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 23  
April 2002 re: letter of Ms. Rebecca D. Conopio, Chief Probation &  
Parole Officer, requesting for supplemental appropriation amounting to  
FIFTEEN THOUSAND PESOS (P15,000.00) for payment of their meal expenses  
incurred during the Therapeutic Community Seminar held last December 17-  
21, 2002;

WHEREAS, the City Budget Officer through 3rd Indorsement dated 13  
May 2002 has recommended that authority be granted the City Accountant  
to charge said request against Provision for Prior Years Obligation, a  
non-office item of CY 2002 Annual Budget;
