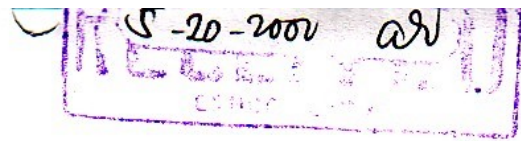
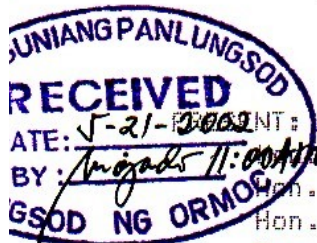

RESOLUTION NO. 2002-126

A RESOLUTION RESPECTFULLY REQUESTING THE HONORABLE CITY  
MAYOR OF ORMOC CARMELO J. LOCSIN TO INITIATE THE  
NECESSARY STEPS FOR THE URGENT RECOVERY OF THE  
UNUSED LOT SPECIFICALLY LOT NO. 2213-B-1 AND THE  
ABANDONED DOTC BUILDING SITUATED ACROSS THE NEW ORMOC  
NATIONAL HIGH SCHOOL (NOCNHS) CONSIDERING THAT SAID  
PROPERTY IS NO LONGER USED TO BE USED AS CLASSROOMS FOR  
THE SATELLITE CAMPUS OF THE LIT.

WHEREAS, it can be recalled that the Seventh Municipal Board of  
Ormoc City passed Resolution No. 78, dated 05 June 1975, entitled: "A  
RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO EXECUTE A COMMON DEED  
OF DONATION TO THE DEPARTMENT OF AGRARIAN REFORM, THE BOARD OF  
TRANSPORTATION, THE BUREAU OF POSTS, AND THE NATIONAL GRAINS AUTHORITY  
OVER PORTIONS OF LOT NO. 2213 AT THE GOVERNMENT CENTER SITE, WITH A  
PROVISION THAT THE SAME BE RETURNED TO THE CITY GOVERNMENT IF NO LONGER  
NEEDED";

WHEREAS, the condition set forth in that said Deed of Donation was  
that the property shall be returned to the City Government of Ormoc if  
the same is no longer needed;

WHEREAS, taking into consideration the fact that the DONEE has not  
used the property for several years, the City Government of Ormoc finds  
it necessary to recover said property based on the condition set forth  
in the aforementioned resolution;



WHEREAS, this august Body finds it proper to request the City Mayor to initiate the necessary steps for the urgent recovery of the unused lot and the abandoned DOTC building erected and no longer used and once recovered, to allow it to be used by LIT satellite school as its classroom;

WHEREFORE, foregoing premises considered, on motion of City Councilor Nepomuceno P. Aparis I, Chairman, Committee on Public Properties, jointly seconded by City Councilors Ruvinieu E. Mendola and Chiqui B. Labagala; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution RESPECTFULLY REQUESTING THE HONORABLE CITY MAYOR OF ORMOC CARMELO J. LOCSIN TO INITIATE THE NECESSARY STEPS FOR THE URGENT RECOVERY OF THE UNUSED LOT SPECIFICALLY LOT NO. 2213-B-1 AND THE ABANDONED DOTC BUILDING SITUATED ACROSS THE NEW ORMOC NATIONAL HIGH SCHOOL (NOCNHS) CONSIDERING THAT SAID PROPERTY IS NO LONGER USED TO BE USED AS CLASSROOMS FOR THE SATELLITE CAMPUS OF THE LIT;

ADOPTED, May 16, 2002.

RESOLVED, FURTHER, to furnish copies of this resolution each to the Undersecretary, DOTC, Manila; the Regional Director, DOTC, Tacloban City; to His Honor, the City Mayor Carmelo J. Locsin; the President LIT, Tacloban City; the President, PTCA, LIT Satellite School; the City Administrator, the City Legal Officer, and others concerned, -in Ormoc City;
