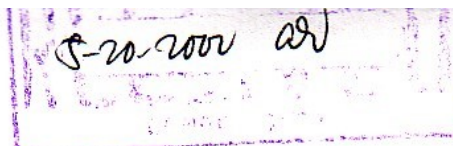
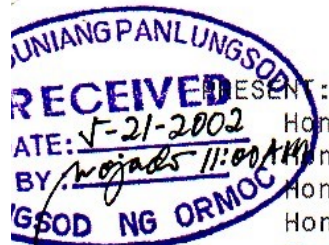

and recognition, hence, must be given due course of action;


WHEREFORE, on MASS MOTION of the Body; be it

FOR HIS INVALUABLE SERVICE TO THE ORMOCANONS;


