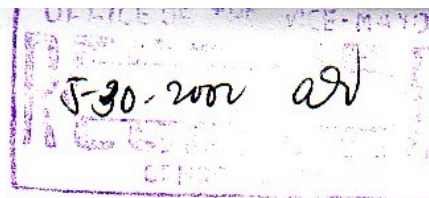
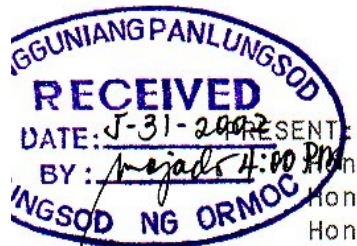

WHEREAS, Ormoc City has a new slaughterhouse located at Barangay  
Macabug, this city;

WHEREAS, the old slaughterhouse which is situated at Barangay  
Alegria, this city is also near the public market and is accessible also  
to all types of fishing boats considering its location which is along  
the shoreline of said barangay;

WHEREAS, with the present increase of Ormoc City's population, this  
Sanggunian believes that a fishport is necessary so as to decongest the  
traffic at the public market, improving the sanitary condition in said  
area and at the same time help boost the city's economy;

WHEREFORE, foregoing premises considered, on motion of City  
Councilor Ruviniou E. Mendola, Chairman, Committee on Market and  
Slaughterhouse, severally seconded by City Councilors Eduardo P. Tan,  
Rafael C. Omega, Jr., Jose S. Serafica & Chiqui B. Labagala; be it

SLAUGHTERHOUSE IS OPERATIONAL;


