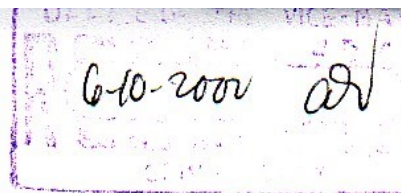
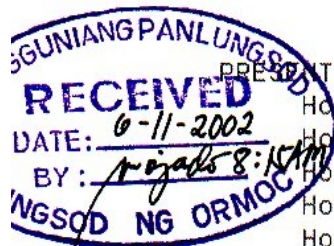

A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE
THE AMOUNT OF SIX HUNDRED THIRTEEN PESOS & 76/100
(P613.76) AGAINST CURRENT APPROPRIATION FOR SALARIES
AND WAGES OF THE ORMOC WATERWORKS DIVISION FOR PAYMENT
OF SALARY STEP INCREMENT OF MR. ADRIANO P. ARCUINO.

WHEREAS, the Sanggunian is in receipt of letter from Engr. Gervacio L. Germano, Jr., Waterworks Superintendent II, requesting for a resolution authorizing the City Accountant to charge against current appropriation the salary step increment of Mr. Adriano Arcuino covering the period from September - December 2001, in the total amount of Six Hundred Thirteen Pesos & 76/100 (P613.76);

WHEREAS, the City Budget Officer through 3rd Indorsement dated 22 May 2002 has recommended that authority be granted the City Accountant to charge above claim against current appropriation for salaries and wages of the said office.

WHEREAS, the City Treasurer, through 4th Indorsement dated 30 May 2002 has certified that fund is available subject however to accounting and auditing rules and procedures;
