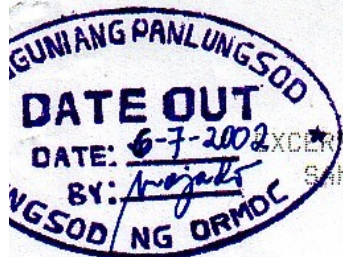


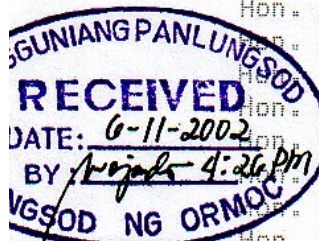

RESOLUTION NO. 2002-143

A RESOLUTION INTERPOSING NO OBJECTION TO THE APPLICATION
OF ORMOC ROCK INCORPORATED FOR AN INDUSTRIAL SAND AND
GRAVEL PERMIT IN BARANGAY MABINI, ORMOC CITY.

WHEREAS, this august Body is in receipt of 1st Indorsement dated 16 April 2002 re: letter (with attachment) from Mr. Lou R. Villamil of Ormoc Rock Inc., requesting for a Sangguniang Panlungsod Resolution interposing no objection to their application for an Industrial Sand & Gravel Permit in Barangay Mabini, this city;

WHEREAS, the Supervising Environmental Management Specialist Engr. Juliana P. Flores, through 3rd Indorsement dated 22 May 2002 has stated that, "It is therefore recommended that this project be given a favorable endorsement from this august Body";

WHEREAS, the residents of Brgy. Mabini, this city, expressed their approval to the said project by way of Barangay Resolution No. 8 of the Barangay Council of Brgy. Mabini, entitled: "A RESOLUTION FAVORABLY ENDORSING THE APPROVAL OF ORMOC ROCK, INC., A CLEARANCE AND PERMIT IN THEIR APPLICATION FOR THE EXTRACTION OF SAND AND GRAVEL ALONG THE RIVERBED OF PANILAHAN RIVER LOCATED AT BRGY.
