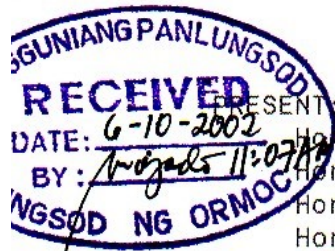

in the evening of May 30, 2002 at the age 92;

WHEREAS, the late Potenciano A. Larrazabal, was a public servant

the number one Councilor of the then Municipality of Ormoc, a known
