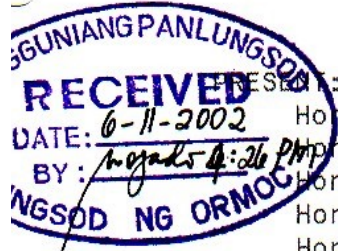

A RESOLUTION REQUESTING THE HONORABLE CITY MAYOR CARMELO
J. LOCSIN TO ALLOCATE ONE NEW SERVICE VEHICLE FOR USE
OF THE MEMBERS OF THE SANGGUNIANG PANLUNGSOD AND
VISITING DIGNITARIES.

WHEREAS, at present, the Sangguniang Panlungsod ng Ormoc has one
(1) unit Toyota Land Cruiser model 70's as its service vehicle which is
used by this Sangguniang staff and personnel;

WHEREAS, being in the public service it is obviously understood
that City Officials like SP members deal directly with their
constituents and as such, attending to their problems and needs is part
of the duty which they pledged to serve;

WHEREAS, in the performance of their official functions it is also
understood that these SP members need also service vehicle for their
official use especially if it concern those far flung barangays which
are seldom attended to;

WHEREAS, as a Department it could not be denied that the
Sangguniang Panlungsod ng Ormoc is oftentimes visited by its
contemporaries from different cities and even some dignataries, local &
foreign, thus the need for a service vehicle for mobility purposes;
