

RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMELO J. LOCSIN, TO ENTER AND SIGN AN AMENDED MEMORANDUM OF AGREEMENT BY AND BETWEEN THE PHILIPPINE HEALTH INSURANCE CORPORATION AND THE CITY OF ORMOC FOR THE IMPLEMENTATION OF THE INDIGENT PROGRAM OR "MEDICARE PARA SA MASA".

WHEREAS, this august Body is in receipt of a letter dated 28 May 2002 from the Honorable City Mayor Carmelo J. Locsin, urgently requesting for a passage of a resolution authorizing him to enter and sign the Amended Memorandum of Agreement by and between the Philippine Insurance Corporation represented by its President and Chief Executive Officer, Francisco T.
