

REPRESENTED BY ITS REGIONAL EXECUTIVE DIRECTOR LEO P. CANEDA, CESO III AND THE NATIONAL FOOD AUTHORITY REPRESENTED BY ITS REGIONAL MANAGER, DANILO L. BONABON.

WHEREAS, this august Body is in receipt of a letter dated 03 June 2002 from the Honorable City Mayor Carmelo J.
