MORENO, REPRESENTATIVE OF THE FIRST DISTRICT OF MISAMIS ORIENTAL TO INTRODUCE AMENDMENTS TO REPUBLIC ACT 7432 TO THE EFFECT THAT ALL SENIOR CITIZENS REGARDLESS OF THEIR ANNUAL INCOME CAN AVAIL OF THE 20% DISCOUNT AS PROVIDED FOR BY THE SAME ACT.
