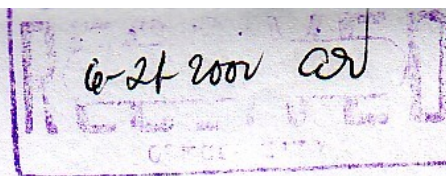
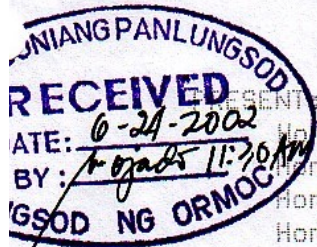

RESOLUTION NO. 2002-154

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMELO
J. LOCSIN TO SIGN AND ENTER INTO A CONTRACT OF USUFRUCT
WITH THE KASAMMAVAFISCO, FOR A LOT LOCATED IN BARANGAY
MATICA-A, ORMOC CITY, IN ORDER TO FACILITATE THE
RELEASE OF FUNDS FROM THE NATIONAL IRRIGATION
ADMINISTRATION (NIA) WHICH WILL BE USED BY THE
COOPERATIVE FOR POST HARVEST FACILITIES.

WHEREAS, this august Body is in receipt of 3rd Indorsement dated 27
May 2002 from the City Legal Officer together with copy of the
Memorandum of Agreement and other related documents in relation to the
request of the Honorable City Mayor Carmelo J. Locsin for authority to
enter into a Contract of Usufruct with KASAMMAVAFISCO for a lot located
at Brgy. Matica-a, this city;

WHEREAS, the request for authority to enter a Contract of Usufruct
is necessary in order to facilitate the release of funds from the
National Irrigation Administration (NIA) which will be used by the
cooperative, Kadaohan, San Jose, Matica-a, Masarayao, Valencia, Farmers
Irrigators Services Cooperative (KASAMMAVAFISCO) herein referred to as
the Usufructuary for post harvest facilities;

WHEREAS, the Sangguniang Panlungsod ng Ormoc, mindful of the plight
of the farmers has considered said request reasonable and beneficial
hence, the same be accorded due course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Nepomuceno P. Aparis I, Chairman, Committee on Public Properties, jointly seconded by City Councilors Gregorio A. Yrastorza, Jr. and Rafael C. Omega, Jr.; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR CARMELO J. LOCSIN TO SIGN AND ENTER INTO A CONTRACT OF USUFRUCT WITH THE KASAMMAVAFISCO, FOR A LOT LOCATED IN BARANGAY MATICA-A, ORMOC CITY, IN ORDER TO FACILITATE THE RELEASE OF FUNDS FROM THE NATIONAL IRRIGATION ADMINISTRATION (NIA) WHICH WILL BE USED BY THE COOPERATIVE FOR POST HARVEST FACILITIES;
