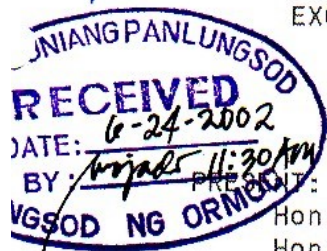

A RESOLUTION EARNESTLY REQUESTING THE ADMINISTRATOR,  
NATIONAL ELECTRIFICATION ADMINISTRATION, TO CONDUCT AN  
EVALUATION ON THE LEYECO V PETITION FOR AN INCREASE OF  
ITS BASIC RATE.

WHEREAS, this august Body is in receipt of Resolution No. 004 s.  
2002 from the Ormoc City Chamber of Commerce, entitled: "A RESOLUTION  
REQUESTING THE SANGGUNIANG PANLUNGSOD TO CONDUCT AN EVALUATION ON THE  
LEYECO V PETITION FOR AN INCREASE OF ITS BASIC RATE";

WHEREAS, as stated in said resolution, the Ormoc City Chamber of  
Commerce has been informed that LEYECO V incurred a revenue loss of ₱83M.  
and has filed a petition with the Energy Regulatory Commission for an  
increase of its basic rate by ₱.72 per kwh;

detrimental to our economy, hence, this request;
