

RESOLUTION NO. 2002-157

RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMELO 1. LOCSIN TO INVEST GOVERNMENT SECURITIES PARTICULARLY TREASURY BILLS AND TREASURY BONDS AT THE BANK OF COMMERCE, ORMOC BRANCH.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 20 June 2002 from the Honorable Carmelo J. Locsin, City Mayor urgently requesting for authority to invest in Government Securities particularly Treasury Bills and Treasury Bonds with the BANK OF COMMERCE, ORMOC BRANCH, being an authorized securities dealer;

WHEREAS, Treasury Bills are government guaranteed papers which the banks purchase from the Bureau of Treasury and sold to interested investors like the City of Ormoc;

WHEREAS, this august Body believes that said request is reasonable hence, the same be accorded due course of action considering that investing in these government securities will not unduly affect the operations of the City Government, instead it is an opportunity to assist our National Government in its economic efforts while maximizing interest income for the benefit of Ormoc City;

WHEREAS, the Honorable City Mayor should inform this Sangguniang Panlungsod as to the amount of investment on Treasury Bills and Treasury Bonds on a weekly/monthly basis;

WHEREFORE, foregoing premises considered, on Motion of City Councilor Rafael C. Omega, Jr., Chairman, Committee on Finance, severally seconded by City Councilors Jose S. Serafica, Gregorio A. Yrastorza, Jr., Jovencio A. Laurente & Porferia Ma. Codilla; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR CARMELO J. LOCSIN TO INVEST GOVERNMENT SECURITIES PARTICULARLY TREASURY BILLS AND TREASURY BONDS AT THE BANK OF COMMERCE, ORMOC BRANCH;
