

A RESOLUTION ENDORSING THE PROPOSED CONVERSION OF ORMOC CITY SCHOOL OF ARTS AND TRADE (OCSAT) INTO ORMOC STATE COLLEGE.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 04 2002 from the Honorable City Mayor Carmelo J. Locsin, re: letter the Honorable Ma. Victoria L. Locsin, Representative of the 4th District of Leyte, requesting this august Body for a resolution that will substantiate the fact that Ormoc City is in need of College;

WHEREAS, at present, with Ormoc City's increasing population, it could not be denied that the demand for new schools is indeed necessary especially those that offers courses like engineering and other more or less related to it;

WHEREAS, being on its third year of transition period, the Ormoc City School of Art and Trade (OCSAT) is offering the following courses: in Secondary Education (BSED), Bachelor of Science Technology (BSIT), Bachelor of Science in (BSIED) and Bachelor of Teaching in Technology and Home Economics (BT-THE);

WHEREAS, if planning to accommodate other courses would wean the conversion of OCSAT into a State College, then this august Body believes that by doing so, many will be benefited not only here in Ormoc but that includes the neighboring municipalities, apparently, this will ease the burden of parents;
