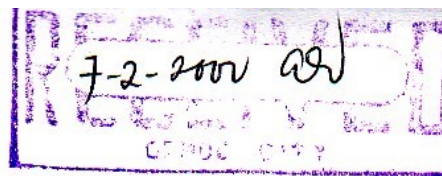
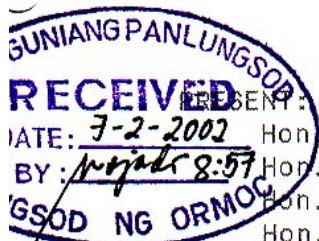

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMELO
J. LOCSIN AND THE SANGGUNIANG PANLUNGSOD REPRESENTED BY
HONORABLE VICE MAYOR CELSO P. ADOLFO TO ENTER INTO A
SCHOLARSHIP CONTRACT WITH MRS. MARCELINA R. ASEO.

WHEREAS, this Sanggunian passed SP Resolution No. 2002-159
