


MENCHAVEZ OF REGIONAL TRIAL COURT, BRANCH 12, PALOMPON, LEYTE AS ACTING PRESIDING JUDGE, REGIONAL TRIAL COURT, BRANCH 35, ORMOC CITY, WHICH GREATLY HELP IN THE DISPENSATION OF JUSTICE TO THE CITY OF ORMOC AND NEIGHBORING TOWNS.

WHEREAS, this august Body is in receipt of a letter from the Officer-In-Charge, Court Management Office, Office of the Court Administrator, Supreme Court of the Philippines together with a copy of Administrative Order No. 74-2002 signed by Acting Chief Justice Josue N.
