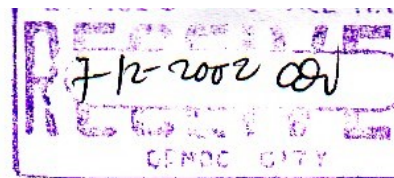
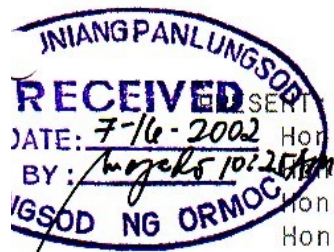

THE CY 2002 SUPPLEMENTAL BUDGET NO. 02 OF BARANGAY DANHUG, THIS CITY;



Chairman/Treasurer of Brgy. Danhug, -all in Ormoc City;


