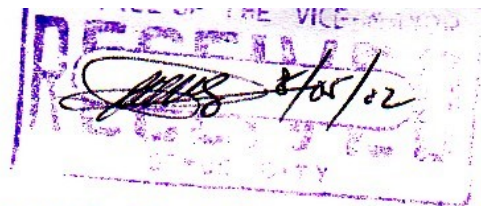

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMELO J. LOCSIN TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT BY AND BETWEEN THE NATIONAL HOUSING AUTHORITY AND THE CITY GOVERNMENT OF ORMOC FOR THE IMPLEMENTATION OF PHASE 1 OF THE ORMOC CITY GOVERNMENT EMPLOYEES HOUSING PROJECT.

WHEREAS, this august Body is in receipt of a copy of Memorandum of Agreement between the National Housing Authority a government corporation represented by its General Manager, Mr. Edgardo D. Pamintuan located at Quezon Memorial, Elliptical Road, Diliman, Quezon City and the City Government of Ormoc, herein represented by its City Mayor, Hon. Carmelo J. Locsin for the implementation of the Ormoc City Government Employees Housing Project, Phase I Ormoc City;

WHEREAS, this project is primarily intended for the homeless employees of the City Government of Ormoc who shall qualify for housing assistance from any of the government end-buyers financing agencies such as the Government Service Insurance System (GSIS), the National Home Mortgage Finance Corporation, the Social Security System (SSS), Land Bank and/or the Home Development Mutual Fund;

WHEREAS, upon review of the said Memorandum of Agreement (MOA), this august Body has found out that the same is reasonable and beneficial, hence, the same be accorded due course of action;
