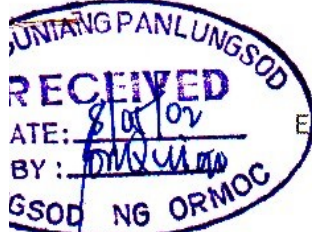
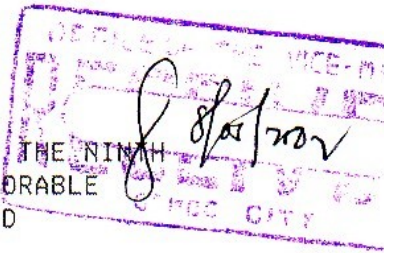

RESOLUTION NO. 2002-174

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMELO
J. LOCSIN TO NEGOTIATE AND ENTER INTO A CONTRACT FOR
THE PURCHASE OF LOTS FOR THE PROPOSED SANITARY LANDFILL
PROJECT IN ACCORDANCE WITH PERTINENT RULES &
REGULATIONS RELATIVE TO THE PURCHASE THEREOF WHICH IS
MOST ADVANTAGEOUS TO THE CITY.

WHEREAS, this Sanggunian is in receipt of a letter dated 02 January
2002 from the Honorable City Mayor Carmelo J. Locsin urgently requesting
this august Body for authority to negotiate and enter into a contract
for the purchase of lots for the proposed sanitary landfill project of
this city;

WHEREAS, pursuant to Sec. 2, Rule XVIII, Part V of DENR
Administrative Order No. 2001-34 otherwise known as the Implementing
Rules and Regulations of Republic Act 9003, LGU's are prohibited the use
of open dumps for its solid waste disposal after the effectivity of said
Act which was passed on January 2001;

WHEREAS, Section 52 (c) of the Act itself has stated that "for
purposes of enforcing the provisions of this Act or its implementing
rules and regulations, any citizen may file an appropriate civil,
criminal or administrative action in the proper courts/bodies against
any public officer who willfully or grossly neglects the performance of
an act specifically enjoined as a duty by this Act or its implementing
rules and regulations;

WHEREAS, taking into consideration the status of the city's present dumpsite wherein the height of the garbage is almost within level of an electric post of LEYECO, the GAWAD PANGULO SA KAPALIGIRAN EXECUTIVE COMMITTEE, in a meeting held at the CLEAN & GREEN Office on July 3, 2002, has come up with a resolution entitled: "A RESOLUTION URGING THE SANGGUNIAN PANLUNGSOD MEMBERS TO ACT ON THE REQUEST OF THE CITY MAYOR HONORABLE CARMELO J. LOCSIN, ASKING FOR AUTHORITY TO PURCHASE A SITE FOR A LANDFILL";

WHEREAS, this august Body has considered said request reasonable and meritorious hence, the same be accorded due course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Eduardo P. Tan, Chairman, Committee on Environmental Control and Natural Resources, jointly seconded by City Councilors Fernando P. Parrilla & Gregorio A. Yrastorza, Jr.; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR CARMELO J. LOCSIN TO NEGOTIATE AND ENTER INTO A CONTRACT FOR THE PURCHASE OF LOTS FOR THE PROPOSED SANITARY LANDFILL PROJECT IN ACCORDANCE WITH PERTINENT RULES & REGULATIONS RELATIVE TO THE PURCHASE THEREOF WHICH IS MOST ADVANTAGEOUS TO THE CITY;

ADOPTED, August 01, 2002.
