RESOLUTION NO. 2002-177

A RESOLUTION SEEKING FROM THE NATIONAL HISTORICAL INSTITUTE (NHI) AN ADVICE ON THE PROPRIETY OF NAMING THE STREET FROM THE JUNCTION OF ORMOC-TACLOBAN TO THE BOUNDARY OF ORMOC AND MERIDA, LEYTE, AS DOMINGO A. VELOSO HIGHWAY.

WHEREAS, this Sanggunian is planning to name the street from the junction of Ormoc-Tacloban to the boundary of Ormoc and Merida, Leyte as Domingo A. Veloso Highway in honor of Domingo A. Veloso, father of the Ormoc City Charter;

WHEREAS, Section 13 Par.(b) of Republic Act 7160, otherwise known as the Local Government Code of 1991, in part provides:

"(b) The Sanggunians of highly urbanized cities and component cities whose charters prohibit their voters from voting for provincial elective officials, hereinafter referred to in this Code as independent component cities, may in consultation with the Philippine Historical Commission, change the name of the following within its territorial jurisdiction.

X X X

(2) City roads, avenues, boulevards, thoroughfares and bridges"; (Emphasis Supplied).

WHEREAS, the same Republic Act 7160 states that the name of a local government unit or a public place, street or structure with historical, cultural or ethnic significance shall not be changed, unless by a unanimous vote of the sanggunian concerned and in consultation with the Philippine Historical Commission (P.H.C.); (Sec. 13 Par. (d) LGC 1991;

WHEREFORE, foregoing premises considered, on motion of City Councilor Demosthenes F. Tugonon, Chairman, Committee on Ways and Means, jointly seconded by City Councilors Ruvineu E. Mendola and Eduardo P. Tan; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution SEEKING FROM THE NATIONAL HISTORICAL INSTITUTE (NHI) AN ADVICE ON THE PROPRIETY OF NAMING THE STREET FROM THE JUNCTION OF ORMOC-TACLOBAN TO THE BOUNDARY OF ORMOC AND MERIDA, LEYTE, AS DOMINGO A. VELOSO HIGHWAY;
