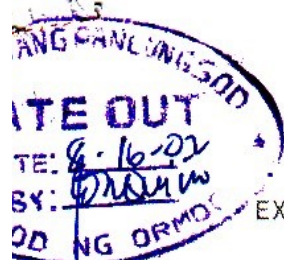
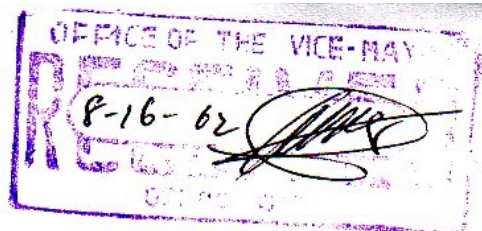

RESOLUTION NO. 2002-184

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR OR HIS
AUTHORIZED REPRESENTATIVE TO ENTER INTO AND SIGN THE
MEMORANDUM OF AGREEMENT (MOA) RELATIVE TO THE CREATION
OF TASK FORCE ORMOC.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 07 August 2002 from the Office of the Honorable City Mayor Carmelo J. Locsin, urgently requesting for authority for him or his authorized representative to sign and enter into said Memorandum of Agreement (MOA) relative to the creation of Task Force Ormoc composed of the Department of Agrarian Reform (DAR, Leyte), Local Government Unit (LGU)- Ormoc City, Department of Public Works and Highways (DPWH), National Irrigation Authority (NIA), Register of Deeds (ROD), Land Bank of the Philippines (LBP), Department of Agriculture (DA), Department of Trade and Industry (DTI), Armed Forces of the Philippines (AFP), Philippine National Police (PNP) - Ormoc, West Leyte Development Formation Center, Inc. (WESLEDEF), Rural Development Institute (RDI - Leyte), Kahugpungan sa Mag-Uumang Ormocanon (KAMAO), Benepisyaryo sa mga Repormang Agraryo sa mga Mag-Uuma sa Ormoc (BRAMO), Panaghugpong sa Mag-Uuma sa Guintugui-an (PAMAG), Ormoc Sugar Planters Association (OSPA), Occidental Leyte Farmer Marketing Cooperative Association (OLFAMCA), and Medium Small Landowners Group (MSLG);

WHEREAS, said Memorandum of Agreement aims to safeguard against instability brought about by some person/sector/organization, and protect one's security of tenure, by providing alternative mechanism/solution in accordance with the mandate of the Constitution, Republic Act No. 7905, issuances, orders, etc. on CARP implementation, tempered with fairness and justness for the benefit of all;

WHEREAS, this august Body believes that said request is reasonable, hence, the same be accorded due course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Gregorio A. Yrastorza, Jr., Chairman, Committee on Agrarian Reform, duly seconded by City Councilor Ruviniu E. Mendola; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR OR HIS AUTHORIZED REPRESENTATIVE TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) RELATIVE TO THE CREATION OF TASK FORCE ORMOC;
