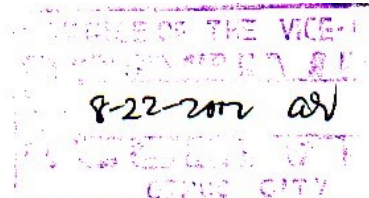
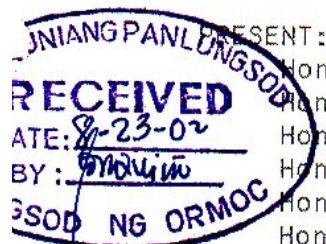

A RESOLUTION EARNESTLY REQUESTING THE HONORABLE CITY  
MAYOR CARMELO J. LOCSIN TO ORDER FOR THE RELOCATION  
SURVEY OF TERRITORIAL BOUNDARIES OF BARANGAYS LAO,  
LILO-AN, LIBERTAD, NAUNGAN AND SAN JUAN, THIS CITY.

WHEREAS, on August 2, 2002, this august Body is in receipt of  
Barangay Resolution No. 21 series of 2002 requesting for a relocation  
survey of the territorial boundaries of the neighboring barangays of  
Barangay Lao;

WHEREAS, the aforecited barangay resolution manifested that some  
neighboring barangays of Barangay Lao had encroached its territorial  
jurisdiction;

WHEREAS, the Barangay officials of the said barangay made the above  
request for the purpose of identifying the specific areas which truly  
belong to Barangay Lao and its adjoining barangays;
