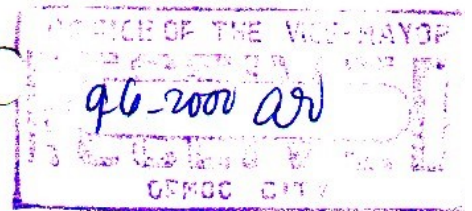

PROGRAM (AIP) 2002 IN THE AMOUNT OF NINE MILLION ONE  
HUNDRED TWENTY THOUSAND PESOS ONLY (P9,120,000.00) TO  
20% DEVELOPMENT FUND AND REQUESTING THE HONORABLE  
SANGGUNIANG PANLUNGSOD NG ORMOC FOR THE APPROVAL OF THE

WHEREAS, per Local Budget Memorandum No. 2002 - 39 final IRA Allocation of Ormoc was reduced from P375,000,000.00 to P299,772,447.00 or a shortfall of P75,000,000.00 and as a result some of the projects approved under AIP 2002 could not be funded, so there is a need for the realignment of projects under CEO considering that the above listed projects are priority and in accordance with the urgent needs of the city;
