

RESOLUTION APPROVING ORDINANCE NO. 01 SERIES OF THE BARANGAY COUNCIL OF BARANGAY BANTIGUE, ENTITLED: "AN ORDINANCE STRICTLY PROHIBITING HANGING OF LAUNDRY AND FENCE CLIMBING IN THE PERIMETER PENCE OF THE BASKETBALL COURT WITH A PENALTY OF P50.00 FINES TO ALL VIOLATORS.

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No. 01 2002 of Barangay Bantigue, this city, entitled: "AN ORDINANCE CTLY PROHIBITING HANGING OF LAUNDRY AND FENCE CLIMBING IN THE STRICTLY PERIMETER FENCE OF THE BASKETBALL COURT WITH A PENALTY OF P50.00 FINES TO ALL VIOLATORS";
