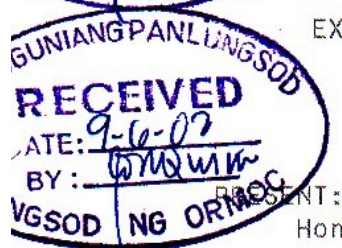
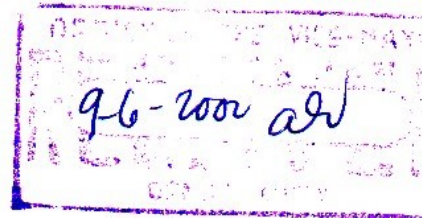

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No. 01
