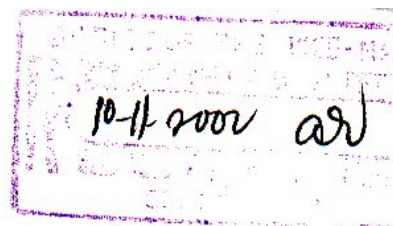

Porferia Ma. Codilla; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution APPROVING

ADOPTED, October 10, 2002.


