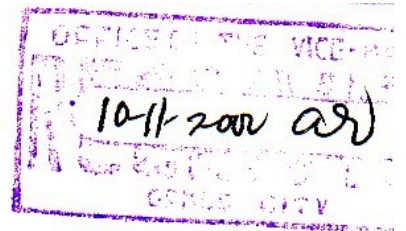

RESOLUTION NO. 2002-203

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMELO
J. LOCSIN, TO ACCEPT AND SIGN A DEED OF DONATION MADE
AND EXECUTED BY MS. LETECIA MONTE IN FAVOR OF THE CITY
GOVERNMENT OF ORMOC INVOLVING A PARCEL OF LAND (ROAD
LOT) LOCATED AT BARANGAY LIBERTAD, ORMOC CITY.

WHEREAS, this Sanggunian is in receipt of a letter dated 01 October
2002 from the Honorable City Mayor Carmelo J. Locsin, requesting for an
authority to accept a DEED OF DONATION made and executed by Ms. Letecia
Monte in favor of the City Government of Ormoc involving a parcel of
land (road lot) located in Barangay Libertad, Ormoc City herein
described as follows:

"A parcel of land designated as Lot 5448-C-9 of the
subdivision plan with PSD-08-01-4039-D, being a portion of Lot
5448-C, PSD-66509, situated in Barangay Libertad, Ormoc City
containing an area of 868 square meters, free from all liens
and encumbrances";

WHEREAS, said road lot has been used by the residents and commuters
for quite sometime and has also been an access road in going to the said
barangay;

WHEREAS, with the said purpose as stated above, this august Body
believes that said request is reasonable and beneficial, hence, the same
is given due course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Nepomuceno P. Aparis I. Chairman, Committee on Public Properties, severally seconded by City Councilors Gregorio A. Yrastorza, Jr., Fe S. Lladoc, Jovencio A. Laurente and Rafael C. Omega, Jr.; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR CARMELO J. LOCSIN, TO ACCEPT AND SIGN A DEED OF DONATION MADE AND EXECUTED BY MS.
