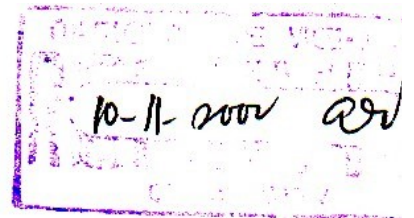
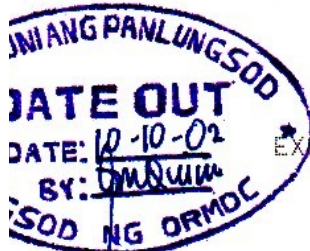

RESOLUTION NO. 2002-204

A RESOLUTION REITERATING THE REQUEST OF THIS SANGGUNIAN  
TO THE MANAGEMENT, HOME DEVELOPMENT MUTUAL FUND (HDMF)  
OR PAG-IBIG, TO PUT UP A SATELLITE OFFICE IN ORMOC CITY  
TO SERVE THE INCREASING NUMBER OF PAG-IBIG MEMBERS.

WHEREAS, the Sangguniang Panlungsod ng Ormoc passed Resolution NO.  
2002-075 dated 21 March 2002 entitled: "A RESOLUTION EARNESTLY  
REQUESTING THE MANAGEMENT, HOME DEVELOPMENT MUTUAL FUND (HDMF) OR PAG-  
IBIG, TACLOBAN BRANCH, TO PUT UP A SATELLITE OFFICE IN ORMOC CITY TO
