

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMELO LOGSIN TO ENTER INTO AN "AMICABLE SETTLEMENT" WITH CEGARDS TO THE BOUNDARY DISPUTE INVOLVING THE CITY OF ORMOO ANOTHE MUNICIPALITY OF KANANGA, SUBJECT TO THE CONDITIONS HEREIN SETFORTH.

WHEREAS, it is of public knowledge that a case is filed concerning boundary dispute between the City of Ormoc and the Municipality of Kananga presently pending at the Third Division of the Supreme Court. docketed as R.R. No. 141375, for Settlement of Boundary Dispute, which case originated from Branch 35, Regional Trial Court, 8th Judicial Region, Ormoc City;

WHEREAS, the Honorable City Mayor of Ormoc Carmelo J. Locsin through a letter dated 21 October 2002 has requested for an authority from this Sanggunian to enter into an "AMICABLE SETTLEMENT" with regards to the boundary dispute involving the Municipality of Kananga and the City of Ormoc;
