

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR,  
CARMELO J. LOCSIN, TO ENTER INTO AND SIGN, FOR AND IN  
BEHALF OF THE CITY OF ORMOC, A MEMORANDUM OF  
UNDERSTANDING WITH THE NATIONAL MEAT INSPECTION  
COMMISSION (NMIC) FOR THE DEPUTATION OF LGU MEAT  
CONTROL OFFICER (MCO)/MEAT INSPECTOR (MI)/LIVESTOCK  
INSPECTOR (LI) TO AUGMENT THEIR CAPABILITIES.

WHEREAS, this Sanggunian is in receipt of a letter dated 07 October  
2002 from the Honorable City Mayor Carmelo J. Locsin, together with a  
copy of the Memorandum of Understanding, requesting for an authority to  
enter into said Memorandum of Understanding between the National Meat  
Inspection Commission (NMIC) and the City of Ormoc;

WHEREAS, said Memorandum of Understanding mentions of the  
deputation of the LGU's Meat Control Officer (MCO), Meat Inspector (MI)  
and Livestock Inspector (LI) to augment their capabilities;

WHEREAS, this august Body has considered said request reasonable  
and beneficial, hence, the same be accorded due course of action;
