RESOLUTION NO. 2002-216

AUTHORIZING THE HONORABLE CITY MAYOR CARMELO SOLUTION LOCSIN TO RELEASE THE TITLE/OWNERSHIP OF NOMELOTS AT THE DSWD CORE SHELTER SITE AT BARANGAY DANKUG, ORMOC CITY, TO THE TWENTY-SIX (26) QUALIFIED TORE SHELTER BENEFICIARIES AS RECOMMENDED BY THE CITY SOCIAL WELFARE AND DEVELOPMENT OFFICER, MRS. MARIETTA CONDITIONS HEREIN SUBJECT TO THE TERMS AND LEGASPI, STATED.

WHEREAS, the City Government of Ormoc has been releasing the Title/Ownership of the homelots to their qualified occupants at different resettlement sites established after the calamity flash-flood brought about by typhoon "URING" on November 5, 1991, to provide shelter tot he flood victims;

WHEREAS, the City Government of Ormoc is of the sincere belief that there can be a faster and better development of these resettlement sites if the ownership/title of these homelots shall be released to the qualified occupants thereof;

WHEREAS, one of these resettlement sites has been identified as the DSWD Core Shelter Site located at Barangay Danhug, this city;

WHEREAS, the Sangguniang Barangay of Danhug passed Resolution No. 2002-00 requesting the Honorable City Mayor, Carmelo J. Locsin for the issuance of the Certificate of Title to the lots presently occupied by the residents who were relocated after Typhoon "URING";



WHEREAS, City Social Welfare and Development Officer, Mrs. Marietta S. Legaspi, favorably recommended the release of lot titles to twenty six (26) qualified allocatees per 1st Indorsement dated 03 October 2002;

WHEREFORE, foregoing premises considered, on motion of City Councilor Nepomuceno P. Aparis I, Chairman, Committee on Public Properties, jontly seconded by City Councilors Jovencio A. Laurente & Ruvinieu E. Mendola; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution authorizing the Honorable City Mayor Carmelo J. Locsin to release the title/ownership of the homelots at the DSWD Core Shelter Site at Barangay Danhug, this city to the Twenty-Six (26) qualified core shelter beneficiaries as recommended by the City Social Welfare & Development Officer, Mrs. Marietta S. Legaspi, subject to the terms and conditions herein stated, to wit:

- That title/ownership of the homelots will be released to qualified occupants sans cost to them;
- 2. That the cost of the individual titling of the nomelots will be borne solely by the beneficiaries the eof;
- 3. That these homelots shall not be transferred or assigned to any person, natural or juridical, within a period of twenty-five (25) years from date of the individual titling thereof, except by hereditary succession, and any transfer or assignment in violation hereof shall be null and void;
- 4. That the lawful owner may mortgage the homelots to any registered financial and/or home-financing institutions, to secure a loan for the construction/repair/remodeling of the house in said lot. In which case the same owner shall seek the approval in writing from the City Mayor of Ormoc;
- 5. That condition three (3) and four (4) hereof, shall be incorporated in the document of transfer from the City Government of Ormoc to the qualified occupants/beneficiaries, and further annotated in the Certificate of Title that may be issued to the qualified occupants/beneficiaries.
