

RESOLUTION NO. 2002-222

A RESOLUTION APPROVING RESOLUTION NO. 16-2002 EMBODYING ORDINANCE NO. 2002-01 OF THE BARANGAY COUNCIL OF BARANGAY MABATO, THIS CITY, ENTITLED: "AN ORDINANCE IMPOSING A TAX ON STORES, OR RETAILERS WITH A FIXED QUEINESS ESTABLISHMENT, OPERATING WITHIN THIS BARANGAY, CHARGES ON OUTDOOR SIGNS, SIGNBOARDS, AND BILLBOARDS, AND FEES ON CLEARANCES AND CERTIFICATIONS ISSUED BY THE BARANGAY TO ANY PERSON."

WHEREAS, this Sanggunian is in receipt of Barangay Resolution No. 2002 from the Barangay Council of Barangay Mabato, this city, embodying Ordinance No. 2002-01 entitled: "AN ORDINANCE IMPOSING A TAX ON STORES, OR RETAILERS WITH A FIXED BUSINESS ESTABLISHMENT, OPERATING WITHIN THIS BARANGAY, CHARGES ON OUTDOOR SIGNS, SIGNBOARDS, BILLBOARDS, AND FEES ON CLEARANCES AND CERTIFICATIONS ISSUED BY BARANGAY TO ANY PERSON; "

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the aforecited ordinance at issue (and all other ordinances of Sangguniang Barangay in Ormoc City), is by law, granted the Power Review as to whether said ordinance is consistent with law and city ${\sf X}$ ${\sf X}$ ordinances; (Sec. 57, 1991 LGC)

WHEREAS, it is the observation of this august Body that the aforesaid ordinance has conformed to pertinent provisions of the Local Government Code, hence, reasonable and within the province of the Sangguniang Barangay of Mabato to legislate;

WHEREFORE, foregoing premises considered, on motion of City Councilor Nepomuceno P. Aparis I, Chairman, Committee on Laws & Ordinances, duly seconded by City Councilor Rafael C. Omega, Jr.; be it
