A RESOLUTION DESIGNATING THE CHAIRMAN, COMMITTEE ON ENVIRONMENTAL CONTROL AND NATURAL RESOURCES OF THE SANGGUNIANG PANLUNGSOD NG ORMOC HONORABLE EDUARDO P. TAN AS MEMBER OF THE PROTECTED AREA MANAGEMENT BOARD (PAMB) OF THE LAKE DANA O NATURAL PARK.

WHEREAS, the DENR is mandated to conserve, protect, develop and manage all protected areas in the country by virtue of R.A. No. 7580 otherwise known as the National Integrated Protected Area System (NIPAS) Act dated June 01, 1992 through the Protected Area Management Board (PAMB) created under Section 11 of the same act;

WHEREAS, the Protected Area Management Board - Lake Danao Natural Park (PAMB - LDNP) represented by its Chairman, Regional Executive Director of the DENR, has sought the assistance of partner agencies for the development and maintenance of existing park facilities for the improvement of the LDNP as an Ecotourism Destination Project;

WHEREAS, the City Government of Ormoc, having recognized the Park's potential for ecotourism has included in its development agenda the development of LDNP as a tourist destination in the region and as such, has designated the Chairman, Committee on Environmental Control & Natural Resources of the Sangguniang Panlungsod ng Ormoc as Member of the Protected Area Management Board - Lake Danao Natural Park (PAMB - LDNP) for proper representation;

WHEREFORE, foregoing premises considered, on motion of City Councilor Demosthenes F. Tugonon, Chairman, Committee on Internal Rules, severally seconded by City Councilors Jose S. Serafica, Fe S. Lladoc & Fernando P. Parrilla; be it


