A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR
CARMELO J. LOCSIN TO ENTER INTO AND SIGN THE MEMORANDUM
OF AGREEMENT BY AND BETWEEN THE DEPARTMENT OF
AGRICULTURE-REGIONAL FIELD UNIT NO. 8 AND THE LOCAL
GOVERNMENT UNIT - ORMOC CITY.

WHEREAS, this august Body is in receipt of 1st Indorsement dated 15
November 2002 from the Acting City Mayor, Atty. Ari G. Larrazabal
requesting for a passage of a resolution authorizing the City Mayor to
enter into and sign the Memorandum of Agreement (MOA) by and between the
Department of Agriculture-Regional Field Unit No. 8 and the Local
Government Unit of Ormoc City;

WHEREAS, said Memorandum of Agreement (MOA) mentions of putting up
one (1) Metarrizhium Laboratory and providing laboratory supplies and
equipment for mass production of metarrizhium and other biological
agents to be used in the control of the Rice Black Bug which
continuously damage rice crop in Southern Leyte and some parts of Leyte;

of the rice growers in Leyte has considered said request meritorious,
