A RESOLUTION RESPECTFULLY ENDORSING TO HER EXCELLENCY PRESIDENT GLORIA MACAPAGAL ARROYO THE REQUEST OF THE HONORABLE CITY MAYOR CARMELO J. LOCSIN TO EXEMPT THE CITY GOVERNMENT OF ORMOC FROM THE PROVISIONS OF BUDGET CIRCULAR 2002-04 AND TO GRANT ALL CITY GOVERNMENT EMPLOYEES OF ORMOC AN ADDITIONAL ₱15,000.00 EACH IN EXTRA CHRISTMAS BONUS INCLUSIVE OF THE ₱5,000.00.

WHEREAS, this august Body is in receipt of a letter dated 11 December 2002 addressed Her Excellency President Gloria Macapagal Arroyo from the Honorable City Mayor Carmelo J.
