

LOCSIN, TO ENTER INTO AND SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, A MEMORANDUM OF AGREEMENT WITH THE SCIENCE EDUCATION INSTITUTE, THE DEPARTMENT OF SCIENCE AND TECHNOLOGY, REGION VIII, THE DEPARTMENT EDUCATION REGION VIII, THE LOCAL GOVERNMENT UNITS/PROVINCES/CITIES AND THE LEYTE SCIENCE TECHNOLOGY FOUNDATION INCORPORATED, FOR IMPLEMENTATION OF THE MOBILE INFORMATION TECHNOLOGY CLASSROOM (MITC) PROJECT.
