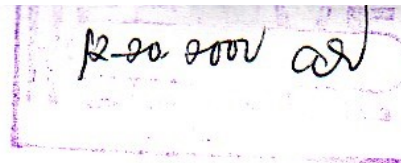

A RESOLUTION REQUESTING THE PNP ORMOC CITY FOR A 24 HOURS CHECKPOINT OF MOTORCYCLES ESPECIALLY ON TANDEM RIDING AND TO ESTABLISH A MOBILE AND STATIONARY CHECKPOINTS IN STRATEGIC PLACES IN ORMOC CITY.

WHEREAS, several shooting incidents have already occurred in the City of Ormoc and in its barangays giving rise to the crime rate at present as compared to the previous years wherein Ormoc was a quiet and peaceful city;

WHEREAS, these shooting incidents does not only involve civilian personnel but it also includes PNP members as well as barangay officials wherein suspects of said crimes usually engaged in tandem riding on motorcycle allowing them for an easy getaway;

WHEREAS, with this kind of "modus operandi", it has come to the knowledge of this Sanggunian that protective measures must be resorted to being the guardians of the rights of its constituents;

WHEREFORE, foregoing premises considered on MASS MOTION of the Body; be it
