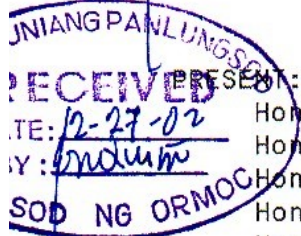
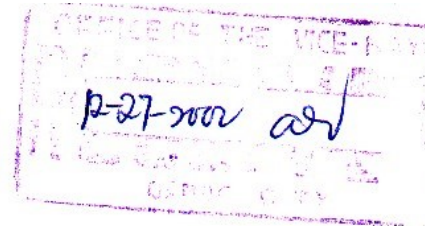



ADOPTED, December 26, 2002.


