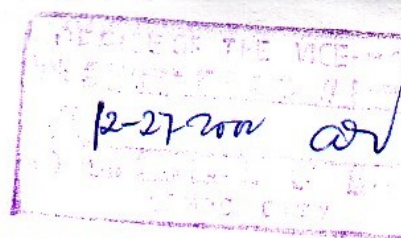

RESOLUTION NO. 2002-248

A RESOLUTION APPROVING ORDINANCE NO. 2000-002 OF THE
BARANGAY COUNCIL OF BARANGAY DISTRICT XVI, ENTITLED:
"AN ORDINANCE PROHIBITING RESIDENTS OF THIS BARANGAY
FROM THE INDISCRIMINATE THROWING OF GARBAGE AND/OR
UNSANITARY DISPOSAL OF ANY WASTE MATERIALS, AND
PROVIDING PENALTIES THEREOF".

WHEREAS, this Sanggunian is in receipt of Ordinance No. 2000-002 of
Barangay District XVI, this city, entitled: "AN ORDINANCE PROHIBITING
RESIDENTS OF THIS BARANGAY FROM THE INDISCRIMINATE THROWING OF GARBAGE
AND/OR UNSANITARY DISPOSAL OF ANY WASTE MATERIALS, AND PROVIDING
PENALTIES THEREOF";

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the
aforecited ordinance at issue (and all other ordinances of the
Sangguniang Barangay in Ormoc City), is by law, granted the Power of

Ordinances, duly seconded City Councilor Fe S. Lladoc; be it
