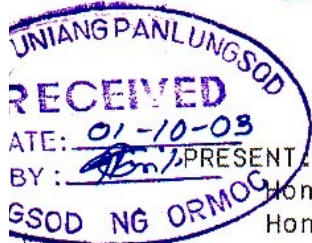

A RESOLUTION REQUESTING ASSISTANCE FROM THE NATIONAL
BUREAU OF INVESTIGATION (NBI) REGIONAL DIRECTOR, REGION
08, TACLOBAN CITY TO CONDUCT THEIR OWN SEPARATE
INVESTIGATION ON THE UNSOLVED KILLINGS IN ORMOC CITY.

WHEREAS, several shooting incidents occurred in the City of Ormoc
including in its barangays which resulted in the death of several
victims including barangay officials;

WHEREAS, the year 2002 was indeed a very unlucky year for Ormoc
City considering that these shooting incidents usually occur in broad
day light and up to the present, it seems that there are no results yet
as far as the investigation of the Police is concerned;

WHEREAS, in order to give the Ormocanons a peace of mind and to
give justice to the victims, this august Body believes that a separate
investigation by the NBI would be of great help;

WHEREFORE, foregoing premises considered, on motion of City
Councilor Demosthenes F. Tugonon, Chairman, Committee on Police & Public
Safety, jointly seconded by City Councilors Ruviniou E. Mendola & Rafael
C. Omega, Jr.; be it

INVESTIGATION ON THE UNSOLVED KILLINGS IN ORMOC CITY;


