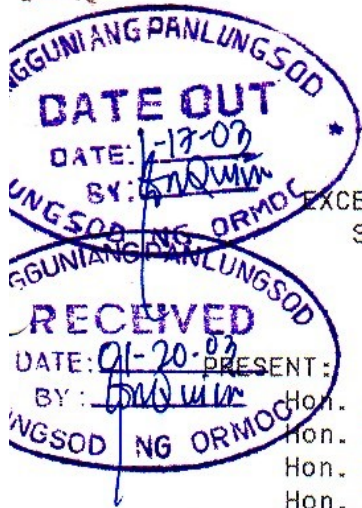
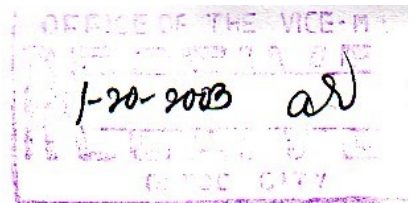

J. LOCSIN, AND THE DEPARTMENT OF PUBLIC WORKS AND
HIGHWAYS, REPRESENTED BY ENGINEER JESUS P. SABANDO OF
THE 4TH LEYTE ENGINEERING DISTRICT FOR THE
IMPLEMENTATION OF THE FOLLOWING PROJECTS:

WHEREAS, this Sanggunian is in receipt of a letter from the


