RESOLUTION NO. 2003-012

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR,
CARMELO J. LOCSIN, TO SIGN FOR AND IN BEHALF OF THE
CITY GOVERNMENT OF ORMOC, A DEED OF DONATION IN FAVOR
OF BARANGAY DISTRICT XXIV INVOLVING A PARCEL OF LAND
WITH AN AREA OF SIXTY SQUARE METERS (60 SQ.M.) OF THE
ABANDONED ANILAO RIVER BED.

WHEREAS, this Sanggunian is in receipt of Barangay Resolution NO.
2002-13, dated 10 November 2002 from Barangay District XXIV, this city
entitled: "A RESOLUTION EARNESTLY REQUESTING THE CITY GOVERNMENT THRU
THE HONORABLE CITY MAYOR CARMELO J. LOCSIN, FOR THE DONATION OF THE
SIXTY SQUARE METERS (60 SQ.M.) OF THE ABANDONED ANILAO RIVER BED TO
BARANGAY DISTRICT XXIV, ORMOC CITY";

left with a small area after the completion of the JICA flood mitigation
project and with this predicament, it is but proper and reasonable to
look for more space so that public service will not be hampered and that

AUTHORIZING THE HONORABLE CITY MAYOR, CARMELO J. LOCSIN, TO SIGN FOR AND
IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, A DEED OF DONATION IN FAVOR
OF BARANGAY DISTRICT XXIV INVOLVING A PARCEL OF LAND WITH AN AREA OF
SIXTY SQUARE METERS (60 SQ.M.) OF THE ABANDONED ANILAO RIVER BED;
