

A RESOLUTION APPROVING BARANGAY ORDINANCE NO. 2003-001 OF
THE BARANGAY COUNCIL OF BARANGAY DISTRICT VIII, THIS
CITY, ENTITLED: "AN ORDINANCE FIXING THE RATES OF THE
BARANGAY CLEARANCE FEES OF BARANGAY DISTRICT VIII,
ORMOC CITY."

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No.
2003-001 of Barangay District VIII, this city, entitled: "AN ORDINANCE
FIXING THE RATES OF BARANGAY CLEARANCE FEES OF BARANGAY DISTRICT VIII,
ORMOC CITY;"

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the
aforecited ordinance at issue (and all other ordinances of the
Sangguniang Barangay in Ormoc City), is by law, granted the Power of
