A RESOLUTION APPROVING BARANGAY ORDINANCE NO. 2003-001 OF
THE BARANGAY COUNCIL OF DISTRICT VI, THIS CITY,
ENTITLED: "AN ORDINANCE PRESCRIBING THE RATE OF
BARANGAY CLEARANCE FEES, PERMITS, AND OTHER CHARGES AND
FEES FOR THE AVAILMENT OR USE OF VARIOUS PROPERTIES AND
SERVICES OF THE BARANGAY."

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No.
2003-01 series of Barangay District VI, this city, entitled: "AN
ORDINANCE PRESCRIBING THE RATE OF BARANGAY CLEARANCE FEES, PERMITS, AND
OTHER CHARGES AND FEES FOR THE AVAILMENT OF USE OF VARIOUS PROPERTIES
AND SERVICES OF THE BARANGAY;"

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the
aforecited ordinance at issue (and all other ordinances of the
Sangguniang Barangay in Ormoc City), is by law, granted the Power of
