

WHEREAS, the road section from Canbantog - Cabingtan and Canbantog Gaas - Liberty this city is very difficult for commuters to pass considering that the condition of which needs repair and rehabilitation;

WHEREAS, the City Government of Ormoc is tasked in maintaining roads within its jurisdiction and part of which are the aforementioned roads that needs the necessary attention;

WHEREAS, the PNOC which is located near the said area, sometimes undertakes to do the repair & rehabilitation of the aforementioned roads so as not to hamper their operations especially when the repair is immediate;

WHEREAS, with this set up, this august Body believes that it would be proper and reasonable that a request be made to the management of PNOC - Ormoc to assist the Ormoc City Government in maintaining the aforementioned roads;
