

## RESOLUTION NO. 2003-023

A RESOLUTION AUTHORIZING THE ICO-CITY TREASURER TO PLACE A HIGH YIELDING SPECIAL SAVINGS OR TIME DEPOSIT AT LAND BANK OF THE PHILIPPINES, ORMOC BRANCH, THE DORMANT CURRENT ACCOUNT AT PHILIPPINE NATIONAL BANK, ORMOC BRANCH, UNDER TRUST FUND, IN THE AMOUNT OF FIVE MILLION EIGHT HUNDRED SEVENTY FOUR THOUSAND SEVEN HUNDRED FIGHTY FIVE & 56/100 (\$5,874,785.56) AND THE INTEREST THEREON SHALL ACCRUE TO THE GENERAL FUND.

WHEREAS, this Sanggunian is in receipt of 2nd Indorsment dated 29 January 2003 from the Honorable City Mayor Carmelo J. Locsin. re: Letter Ms. Evangelina B. Jaingue, DM III, Land Bank of the Philippines, Ormoc Branch and letter of Mr. Angelo I. Roman, ICO - City Treasurer, dated 27 January 2003 requesting that the latter be authorized to place under a high yielding Special Savings or Time Deposit at Land Bank. Ormoc Branch, the dormant current depository accounts the City of has in the amount of \$5,874,785.56 with the Philippine National Bank. Ormoc Branch under Trust Fund and that the interest thereon shall accrue to the General Fund;

WHEREAS, said request was made for the benefit of the City Government of Ormoc and also to improve its deposit balance which will favorably influence pricing of loans and its approval with said bank;

WHEREAS, the Sangguniang Panlungsod ng Ormoc through representation of the Honorable Chairman, Committee on Finance considered said request reasonable, hence, the same be accorded course of action;



WHEREFORE, foregoing premises considered, on motion of City Councilor, Rafael C. Omega, Jr., Chairman, Committee on Finance, jointly seconded by City Councilors Nepomuceno P. Aparis I and Fernando P. Parrilla; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE ICO-CITY TREASURER TO PLACE UNDER A HIGH YIELDING SPECIAL SAVINGS OR TIME DEPOSIT AT LAND BANK OF THE PHILIPPINES, ORMOC BRANCH, THE DORMANT CURRENT ACCOUNT AT PHILIPPINE NATIONAL BANK, ORMOC BRANCH, UNDER TRUST FUND, IN THE AMOUNT OF FIVE MILLION EIGHT HUNDRED SEVENTY FOUR THOUSAND SEVEN HUNDRED EIGHTY FIVE & 56/100 (\$\mathbb{P}\$5,874,785.56) AND THE INTEREST THEREON SHALL ACCRUE TO THE GENERAL FUND;
